The Company has entered several loan agreements with PT Saratoga Investama Sedaya Tbk, Asian Metal Mining Developments Limited, Provident Minerals Pte Ltd. and Goldstar Mining Asia Resources (L) Berhad. All loans attract interest at 10% per annum and classified as unsecured loans.

- Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

The Company anticipates maintaining operating cashflows at a similar level for the time being as it explores options for funding the Sihayo Gold Project pre-construction capital works program, exploration for the coming 12 months including a drilling program at Hutabargot Julu.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

The Company has signed a loan agreement for USD 1.5m with a subsidiary of Merdeka Copper Gold (Merdeka), a listed Indonesian gold producer. Loan details are contained in a release to the ASX dated 30 July 2020. In addition, the Company has appointed Argonaut Securities (Asia) Limited (Argonaut) as financial adviser to explore further funding options and anticipates new capital raising activity to be completed in the near future.

- Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Yes. The company has released the results of the Sihayo Gold Project Definitive Feasibility Study which demonstrates the projects viability. Following the USD 1.5 million Merdeka loan and appointment of Argonaut, the Company is confident of securing additional longer term financing from the broader market, especially given the current gold price and the Company's strong portfolio of exploration prospects in addition to the existing Sihayo Gold project.
